





Women Officers in Regiment of Artillery

In a historic move, the Indian Army is set to commission its first lot of women officers in the artillery regiments later this month. The Officers' Training Academy (OTA) in Chennai will see these women officers pass out after receiving training to handle howitzers and rocket systems. This development comes after women officers have been serving in the Indian Air Force (IAF) and Indian Navy for several years.

The women officers who pass out of OTA this month will be commissioned into units like air defence, signals, engineers, aviation, ASC, and ordnance. Several of them are expected to be inducted into the Regiment of Artillery for the first time. However, they will first serve in the units they are assigned to and then undergo artillery-specific courses, which will begin with gunnery training on the 105mm Indian field guns.

Australia's Gender Pay Gap Law

Australia has recently passed a new law aimed at addressing the gender pay gap in the country. The law requires companies with over 100 employees to reveal their gender pay gaps, a move towards transparency that is expected to make businesses accountable for their actions. The new law, which takes effect early next year, will require the Workplace Gender Equality Agency (WGEA) to publicly publish details of companies' gender pay gaps.

The new legislation is an important step towards improving the economic security of women in Australia. The country's Sex Discrimination Commissioner Kate Jenkins has stated that the change will play an important role in encouraging business, industry, and government to be more active in their efforts to reduce the gender pay gap.

Finland's NATO Membership

On April 4 this year, Finland officially became a member of the NATO, marking a definitive shift in Europe's post-World War II alignment and isolating Russia further. The move ends over 70 years of military non-alignment for the small Nordic country that shares a 1,340-km border with Russia. During the Cold War era, the policy of neutrality between the USSR and the West was known as "Finlandisation", and this had been one of the options discussed for Ukraine before Russia invaded it. Finland is now the 31st NATO member.

For Finland, joining NATO brings better security, but the country is losing out on significant trade and tourist revenue it was making from Russia and its position as the West's gateway to the East. Russia has criticized Finland's move and said it would fray relations with Moscow, undo its status as a confidence-building presence in the Baltic Sea and Europe, and raise the risk of the Ukraine conflict escalating further.

Food Conclave 2023

On April 28 and 29, the Telangana government will host the Food Conclave-2023. The event is an annual brainstorming session that brings together 100 thought leaders from the agri-food industry. The conclave's objective is to identify the main challenges and opportunities for the growth of the Indian agri-food sector in the present decade.

The event will have five thematic tracks that cover different aspects of the agri-food sector. Agriculture (green), edible oil (yellow), dairy (white), meat and poultry (pink), and aquaculture (blue) will be the main focus areas.

World Energy Transitions: Outlook 2023

The International Renewable Energy Agency (IRENA) released its World Energy Transitions: Outlook 2023 report, highlighting the need for a more aggressive approach to transition towards renewable energy sources. The report outlines the current state of renewable energy generation and provides insights into the challenges that need to be overcome to achieve the goals outlined in the Paris Agreement.

Renewable Energy Generation: The Current State

Renewable energy has come a long way in recent years, and the report reveals that 40% of installed power generation globally comes from renewable sources. In 2022, renewables accounted for 83% of global power additions, indicating the growing trend towards cleaner energy. However, there is still a lot of work to be done to achieve the target set by the Paris Agreement to limit global warming to 1.5°C above pre-industrial levels.

The Challenges Facing the Energy Transition

The report identifies two significant events that have compounded the challenges facing the energy transition: the Covid-19 pandemic and the Ukraine crisis. Both of these events have slowed down progress towards achieving renewable energy targets. Additionally, the report highlights that Africa accounted for only 1% of additional renewable energy capacity in 2022, indicating the need for more investment in the region.

The Targets for the Energy Transition

To keep the 1.5°C target alive, the report outlines that over 10,000 GW of renewable energy deployment must be achieved by 2030. Additionally, the report suggests that yearly investments of over \$5 trillion are needed to stay on the 1.5°C pathway. To achieve this, the report highlights that 80% of planned investment by 2030 must go towards transition technologies, and USD 1 trillion of planned annual fossil fuel investment must be redirected towards transition technologies and infrastructure.

Priority Pillars of the Energy Transition

The report outlines three priority pillars of the energy transition: physical infrastructure, policy and regulatory enablers, and a well-skilled workforce. All three pillars are crucial for driving the transition towards renewable energy sources. The report highlights that investing in these pillars will lead to economic growth, job creation, and a reduction in greenhouse gas emissions.

The Emissions Gap in 2050

The report reveals that if current pledges and plans are implemented, there will still be an emissions gap of 16 gigatonnes (Gt) in 2050. This indicates that more action needs to be taken to achieve the targets set by the Paris Agreement.

Reducing Carbon Dioxide Emissions

The report suggests that fully implementing nationally determined contributions (NDCs), long-term low greenhouse gas emission development strategies (LT-LEDs), and net-zero targets can help reduce carbon dioxide (CO2) emissions by 6% by 2030.

World Health Day

World Health Day is celebrated globally on April 7 every year to raise awareness about physical, mental, and social wellness. It is an initiative of the World Health Organization (WHO) to promote health and well-being for all individuals. The day aims to raise awareness about health issues, encouraging conversations and discussions about ways to maintain good health, and advocating actions on a global scale. This year, it marks the 75th anniversary of the World Health Organization, which was established in 1948.

Each year, WHO picks a specific theme relevant to the wellness and medical field. The theme for World Health Day 2023 is 'Health For All".

The theme highlights the public health successes of the WHO that played a role in improving the quality of life of the past seven decades. It also calls on the world to address the present and future health-related challenges.

National Medical Council's Guidelines on Professional Responsibilities of Students and Teachers:

Jupiter Icy Moons Explorer (Juice) Mission

The jupiter ICy moons Explorer (JUICE) is a mission by the European Space Agency (ESA) set to launch on April 13, 2023, from the European Spaceport in Kourou, French Guiana.

The primary focus of JUICE's science goals is the Jupiter system, with a particular emphasis on Ganymede as a planetary body and potential habitat. The mission objectives for Ganymede include the characterization of the ocean layers and detection of putative subsurface water reservoirs, topographical, geological, and compositional mapping of the surface, studying the physical properties of the icy crusts, characterizing the internal mass distribution, dynamics, and evolution of the interiors, investigating the exosphere, and studying Ganymede's intrinsic magnetic field and its interactions with the Jovian magnetosphere.

What is Siren sphagnicola?

Siren sphagnicola is a recently discovered species of elongate, eel-like aquatic salamanders that inhabits seepage areas in the eastern Gulf Coastal Plain of the United States.

Siren sphagnicola belongs to the family Sirenidae, which is part of the order Caudata (salamanders). This family comprises two genera, Siren and Pseudobranchus. All living sirens, including Siren sphagnicola, have lidless eyes, external gills with comb-like filaments and laterally compressed tails with fin blades. What makes sirens unique within salamanders is their lack of pelvic girdles and associated hindlimbs.

Indian Space Policy 2023

The Indian government recently approved the Indian Space Policy 2023, with the aim of institutionalizing and facilitating private sector participation in the Indian space sector. The policy's approval by the Cabinet Committee, helmed by Prime Minister Narendra Modi, is a significant step towards transforming India into a major space power.

Under the new policy, the Indian Space Research Organisation (ISRO) will focus on research and development of advanced space technologies. The private players' participation in the space sector is crucial to increase India's current share of less than two per cent in the global space economy to 10 per cent in the future.

NSIL's Role in Carrying Out Strategic Activities

New Space India Limited (NSIL) will carry out strategic activities related to the space sector. NSIL will work in a demand-driven mode, according to Union Minister Jitendra Singh. This means that private players will have access to end-to-end space activities, including building rockets, satellites, launch vehicles, data collection, and dissemination.

In-Space as the Interface between ISRO and Private Sector Enterprises

Indian National Space Promotion and Authorization Centre (In-Space) serves as a liaison between ISRO and private sector enterprises. In-Space will enable private players to participate in the space sector by offering a simplified regulatory environment for private entities' operations. The policy's approval is expected to pave the way for the Indian space sector's privatization and contribute to the country's economic growth.

The Rise of Private Sector Companies in India's Space Industry

Over 100 active space companies have been operating in India since 2012, according to the Economic Survey of India. Private sector companies like SpaceX, led by Elon Musk, have become a popular choice for space missions around the world. The Indian government's approval of the Indian Space Policy 2023 is expected to encourage more private sector companies to enter the space sector.

Muthuvans and Human-Animal Conflicts

The Muthuvans are a tribe of cultivators who dwell in the hilly regions of Tamil Nadu's Coimbatore and Madurai and Kerala's Adimali and Devikulam forest regions of Idukki district. They have a rich cultural heritage and are known for

Their name, Muthuvar, means elders.

The report further highlights that the Nilgiri cluster that is Nagarahole to BRT Hills in Karnataka has the largest tiger population in the world. However, the tiger populations in areas outside of the reserves such as Wayanad landscape, BRT Hills, and the tiger areas on Goa-Karnataka border have decreased significantly.

States Reporting a Decline in Tiger Populations

The report has shown a decline in tiger populations in the Indian states of Jharkhand, Odisha, Chhattisgarh, Andhra Pradesh and Telangana. This data highlights the need for increased protection and conservation measures in these areas.

Increase in Tiger Populations in Other Landscapes

The report indicates that several landscapes have shown a substantial increase in tiger population, such as Shivalik and Gangetic floodplain, central India, northeastern hills, Brahmaputra flood plains, and Sundarbans. This growth is promising and a testament to the conservation efforts that have been implemented in these areas.

International Big Cat Alliance
